## QUALIFYING FOR THIS PROGRAM

- Your salary or earnings is currently being deducted under pay-as-you-earn.
- Should have GCSEs or equivalent in English and Maths (or we will need to ensure you get level 2 Functional Skills in English and Maths which must be achieved during the apprenticeship).
- At least an undergraduate degree or other professional qualifications. If you do not have a degree, but have a few years of supervisory/managerial experience you may still qualify. Submit your CV for evaluation.

## COSTS AND FUNDING

The apprentice pays nothing (apart from the optional MBA).

Basically, if the employer has a payroll bill of over £3 million per annum, it pays into the apprenticeship levy and there is no further fees for it to pay for apprenticeship training.

However, if your company has a wage bill of less than £3 million per year (or if your levy paying organisation has used up all its levy funds) there is a co-investment route available. This is where the government pays 95% of the cost. Under the co-investment route your employer's cost is spread over the 15 month duration of the program.

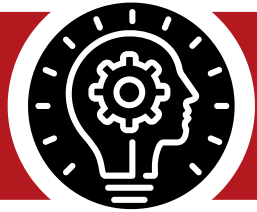
